# Siklus Ikan Salmon

## The Salmon's Circle

Siklus hidup seekor ikan salmon terdiri dari beberapa fase yang menakjubkan dan penuh dengan filosofi perjuangan. Siklus tersebut sejalan dengan semangat yang diemban oleh LPDP. Seekor ikan salmon lahir dan tumbuh di air tawar. Ketika cukup umur, seekor ikan salmon akan bermigrasi ke air laut. Ikan salmon akan kembali dan melawan arus menuju air tawar untuk berkembang biak.

Hal tersebut menganalogikan bagaimana LPDP membantu putra-putri terbaik bangsa untuk menempuh pendidikan di berbagai penjuru dunia dan memberikan tempat kembali di Indonesia untuk mengabdikan diri. Selain itu, kegigihan ikan salmon melawan arus merepresentasikan tekad LPDP untuk terus membantu dan mengayomi setiap penerima beasiswa agar tetap bisa meraih mimpi dalam berbagai tantangan, termasuk pada masa pandemi.

The life cycle of a salmon fish consists of several phases that are amazing and full of philosophies of resilience. The cycle is in line with the spirit carried by the LPDP. A salmon fish is born and grows in freshwater. When old enough, a salmon will migrate to the ocean. Then, it will migrate back and swim against the current, back into the freshwater to breed.

This is in line with how LPDP helps the nation's best sons and daughters to study in many places of the world and provides a place back in Indonesia to devote themselves. In addition, the persistence of salmon against the current represents LPDP's determination to continue to help and protect each scholarship recipient so that they can continue to achieve despite the various challenges, including during the COVID-19 pandemic.

**Tentang LPDP**  
About LPDP

**Lembaga Pengelola Dana Pendidikan (LPDP) merupakan satuan kerja non-eselon pada Kementerian Keuangan yang menerapkan Pola Pengelolaan Keuangan Badan Layanan Umum (BLU) dan mengelola Dana Abadi Pendidikan (DAP) sesuai dengan ketentuan peraturan perundang-undangan. Definisi organisasi ini diatur pada pasal 1 angka 4 Peraturan Presiden Nomor 12 tahun 2019 tentang Dana Abadi Pendidikan.**

Indonesia Endowment Fund for Education Agency is a non-echelon work unit at the Ministry of Finance that implements the Financial Management Pattern of the Public Service Agency (BLU) and manages the Education Endowment Fund (DAP) in accordance with the provisions of the legislation. The definition of this organization is regulated in Article 1 point 4 of Presidential Regulation Number 12 of 2020 concerning the Education Endowment Fund.



Dana Abadi Pendidikan (DAP) yang dikelola LPDP adalah dana yang bersifat abadi untuk menjamin keberlangsungan program pendidikan bagi generasi berikutnya yang tidak dapat digunakan untuk belanja (pasal 1 angka 1 Peraturan Presiden Nomor 12 tahun 2019). Dana Abadi Pendidikan dapat bersumber dari Dana Pengembangan Pendidikan Nasional (DPPN) termasuk akumulasinya, pendapatan investasi, dan/atau sumber lain yang sah.

Hasil investasi dana abadi pendidikan diperlakukan sebagai Pendapatan Negara Bukan Pajak (PNBP) dan digunakan untuk membiayai 2 layanan utama LPDP yakni Layanan Beasiswa untuk jenjang pendidikan Magister dan Doktoral serta Layanan Pendanaan Riset untuk riset komersial dan/atau implementatif.

The Education Endowment Fund (DAP) managed by LPDP is an enduring fund to ensure the continuity of education programs for the next generation that cannot be used for spending (article 1 number 1 of Presidential Regulation Number 12 of 2020). The Endowment Fund for Education can be sourced from the National Education Development Fund (DPPN) including its accumulation, investment income, and/or other legitimate sources.

The investment results of the education endowment fund are treated as Non-Tax State Revenue (PNBP) and are used to finance the LPDP's two main services, namely Scholarship Services for Masters and Doctoral education levels and Research Funding Services for commercial and/or research implementation.

Kinerja yang tinggi merupakan produk dari organisasi yang kuat, dan organisasi publik yang kuat tidak lain adalah produk dari regulasi yang kuat. Pada tahun 2020, penguatan organisasi LPDP dicapai dengan ditetapkannya Peraturan Presiden Nomor 12 tahun 2019 tentang Dana Abadi Pendidikan. Peraturan ini secara umum mengatur mengenai struktur baru Dewan Penyantun serta Dewan Pengawas, definisi serta komposisi dari Dana Abadi Pendidikan, serta tata kelola Dana Abadi Pendidikan tersebut. Peraturan Presiden tersebut secara tegas memperkuat posisi LPDP sebagai pengelola dana abadi di Indonesia, yang sekaligus dapat meningkatkan kualitas layanan LPDP kedepannya.

With all the blessings and graces from God Almighty, we are proud to present this 2020 Annual Report of the Indonesia Endowment Fund for Education Agency to all stakeholders, as well as to all Indonesian people as the ultimate stakeholder and recipient of services provided by public sector agencies in Indonesia.

This 2020 Annual Report of the Indonesia Endowment Fund for Education Agency is themed The Resilience of Scholarship Service and Research Funding in the Midst of the COVID-19 Pandemic

High performance is the product of a strong organization, and a strong public organization is nothing but the product of strong regulation. In 2020, the strengthening of the LPDP organization was achieved with the stipulation of Presidential Regulation No. 12 of 2019 concerning the Education Endowment Fund. This regulation generally manages the new structure of the Board of Trustees and the Supervisory Board, the definition and composition of the Education Endowment Fund, and the management of the Education Endowment Fund. The Presidential Regulation explicitly strengthens LPDP's position as the manager of endowments in Indonesia, which at the same time can improve the quality of LPDP's services in the future.

Selain dari sisi penguatan regulasi, LPDP juga melakukan penguatan dari sisi teknis operasional. LPDP berkomitmen untuk beradaptasi secara berkelanjutan terhadap disrupsi teknologi dan persepsi masyarakat pengguna layanan yang mayoritas adalah kalangan milenial, dengan melakukan modernisasi atas kantor layanan. LPDP telah melakukan perpindahan kantor pada bulan Maret 2019, dari kantor di Gedung Ali Wardhana ke Gedung Danadyaksa di bilangan Cikini, Jakarta Pusat. Kantor baru LPDP didesain sesuai konsep *open office*, yang mendukung penuh proses kolaborasi dan sinergitas, serta memberikan kesan positif bahwa organisasi LPDP adalah organisasi yang terbuka, transparan, dan amanah dalam menjalankan pengelolaan Dana Abadi Pendidikan.

Dengan penguatan regulasi dan modernisasi kantor, kinerja layanan juga mengalami peningkatan pada tahun 2020. Secara akumulatif, jumlah Dana Abadi yang dikelola LPDP per 31 Desember 2020 adalah Rp70,107 Triliun. DPPN ini dikelola dengan diinvestasikan pada berbagai instrumen investasi berisiko rendah dan menengah seperti deposito, obligasi SBN, dan obligasi BUMN. Hasil pengelolaan DPPN diakui sebagai Pendapatan Negara Bukan Pajak (PNBP). Pada tahun 2020, realisasi PNBP mencapai Rp3,909 Triliun. Realisasi ini tercapai 104,73% dari target PNBP tahun 2020, ini merupakan wujud kinerja dan komitmen LPDP dalam meningkatkan imbal hasil pengelolaan Dana Abadi yang diamanahkan kepada LPDP.

Pada tahun 2020 di tengah adanya pandemi secara global, layanan beasiswa sebagai salah satu komitmen pemerintah untuk menciptakan sumber daya manusia Indonesia yang unggul tetap dilaksanakan secara terbatas. LPDP melakukan seleksi dan rekrutmen beasiswa dengan beradaptasi melalui penyederhanaan proses bisnis seleksi. Jumlah penerima beasiswa yang dinyatakan lolos seleksi pada tahun

Apart from strengthening regulations, LPDP also strengthens operational technical aspects. LPDP is committed to adapting sustainably to technological disruptions and public perceptions of service users, the majority of whom are millennials, by modernizing our service offices. LPDP moved offices in March 2019, from the office at the Ali Wardhana Building to the Danadyaksa Building in the Cikini area, Central Jakarta. The new LPDP office is designed according to the open office concept, which fully supports the collaboration and synergy process, and gives a positive impression that the LPDP organization is an open, transparent, and trustworthy organization in managing the Education Endowment Fund.

With the strengthening of regulations and office modernization, our service performance also improved in 2020. Accumulatively, the amount of the Endowment Fund managed by LPDP as of December 31, 2020 is IDR 70,107 Trillion. The DPPN is managed by investing in various low and medium risk investment instruments such as time deposits, government bonds, and state-owned enterprises bonds. The results of DPPN management are recognized as Non-Tax State Revenue (PNBP). In 2020, the realization of PNBP reached IDR 3.909 trillion. This realization was achieved by 104.73% of the PNBP target in 2020. This is a form of LPDP's performance and commitment in increasing the yield on the management of the Endowment Fund which is mandated to LPDP.

In 2020, in the midst of a global pandemic, scholarship services as one of the government's commitments to create superior Indonesian human resources continued to be implemented in a limited manner. LPDP conducts selection and recruitment of scholarships by adapting simplification in the selection business process. The number of scholarship recipients who have passed the selection in 2020 is 280 people. LPDP also funded

2020 sejumlah 280 orang. LPDP juga mendanai Program Kampus Mengajar yang diinisiasi oleh Kementerian Pendidikan dan Kebudayaan dengan jumlah penerima beasiswa sebesar 2.389 orang. Kolaborasi ini akan menjadi dilaksanakan dalam rangka memperluas manfaat pengelolaan dana abadi sehingga dapat diakses secara merata. Selain itu, Mahasiswa On Going yang sedang menjalankan studi di dalam dan luar negeri dalam pembiayaan beasiswa dari LPDP per 31 Desember 2020 sejumlah 7.988 orang.

Adapun jumlah alumni LPDP per 31 Desember 2020 adalah 12.597 orang. Alumni LPDP saat ini telah tersebar pada berbagai institusi publik dan privat, berkontribusi pada negeri dalam bidang tugas dan keahliannya masing-masing. Alumni LPDP melalui organisasi Mata Garuda secara aktif mendekati masyarakat dan menyelenggarakan kegiatan yang bermanfaat bagi lingkungan sekitarnya baik di level daerah maupun secara nasional.

Dari sisi Layanan Pendanaan Riset, LPDP telah menandatangani pendanaan untuk 60 judul riset baru dan 18 kontrak lanjutan. Riset yang dibiayai LPDP adalah riset yang bersifat kompetisi, mandatori, invitasi, dan kolaborasi internasional. Inovasi penelitian merupakan prasyarat suatu negara berkembang menjadi negara maju, dan LPDP berkomitmen ikut mewujudkan visi tersebut dengan pendanaan riset berkelanjutan.

Sumber daya manusia adalah faktor penting dalam rangka menjawab tantangan Indonesia yang ada saat ini dan di masa yang akan datang. Dunia terus berubah sehingga menciptakan generasi masa depan bangsa yang memiliki pengetahuan global dan kemampuan untuk beradaptasi menjadi hal yang penting untuk dilakukan. Dalam hal ini, LPDP sebagai salah satu organisasi sektor publik yang berupaya melaksanakan tujuan tersebut dengan terus memberikan

the Teaching Campus Program initiated by the Ministry of Education and Culture with a total of 2,389 scholarship recipients. This collaboration will be implemented in order to expand the benefits of endowment management so that it can be accessed equitably. In addition, on-going students who are currently studying at home and overseas under scholarship funding from LPDP as of December 31, 2020, totaled 7,988 people.

The number of LPDP alumni as of December 31, 2020 is 12,597 people. LPDP alumni are now scattered in various public and private institutions, contributing to the country in their respective fields of duty and expertise. LPDP alumni through the Mata Garuda organization actively approach the community and organize activities that are beneficial to the surrounding environment, both at the regional and national level.

In terms of Research Funding Services, LPDP has signed funding for 60 new research titles and 18 follow-up contracts. Research funded by LPDP is research that is competitive, mandatory, inviting, and international collaboration. Research innovation is a prerequisite for a developing nation to become a developed country, and LPDP is committed to realizing this vision through sustainable research funding.

Human resources are an important factor in responding to Indonesia's current and future challenges. The world continues to change so that it is important to create future generations of nations who have global knowledge and the ability to adapt. In this case, LPDP is one of the public sector organizations that seeks to implement these goals by continuing to provide support for the development of superior Indonesian human resources. LPDP can carry out its vision optimally with the support and synergy of various

### Ringkasan Eksekutif Executive Summary

#### 1. Dana Abadi Pendidikan (berupa DPPN)

Dana Abadi yang dikelola LPDP per 31 Desember 2020 berjumlah Rp70,107 Triliun. Jumlah tersebut adalah akumulasi dari DPPN sejak 2010 dan Dana Abadi lainnya yang dititipkan kepada LPDP.

Dana Abadi yang dikelola LPDP saat ini terdiri dari 4 jenis yakni Dana Abadi Pendidikan (DPPN) sebesar Rp61,1 Triliun, Dana Abadi Penelitian sebesar Rp4,99 Triliun, Dana Abadi Perguruan Tinggi sejumlah Rp3 Triliun, serta dicairkan juga Dana Abadi Kebudayaan sebesar Rp1 Triliun.

#### 1. Education Endowment Fund (in the form of DPPN)

Perpetual Funds managed by LPDP as of December 31, 2020 amounted to IDR 70,107 Trillion. This amount is the accumulation of DPPN since 2010 and other Endowments that have been deposited with LPDP.

The Endowment Fund managed by the LPDP currently consists of 4 types, namely: The Education Endowment Fund (DPPN) of IDR 61.1 Trillion, the Research Endowment Fund of IDR. 4.99 Trillion, the Higher Education Endowment Fund of IDR. 3 Trillion, and the already-disbursed Cultural Endowment Fund of IDR 1 Trillion.



LPDP Organizational Structure Based on PMK 143/PMK.01/2016 regarding OTK LPDP


#### 4. Struktur Organisasi

Dasar hukum tata kerja dan organisasi LPDP adalah Peraturan Menteri Keuangan (PMK) Nomor 143/PMK.01/2016 tentang Organisasi dan Tata Kerja LPDP. Dalam melaksanakan tugasnya, LPDP bertanggung jawab kepada Menteri Keuangan melalui Sekretaris Jenderal.



#### 4. Organizational Structure

The legal basis for the work procedure and organization of the LPDP is the Minister of Finance Regulation (PMK) Number 143/PMK.01/2016 concerning the Organization and Work Procedure of the LPDP. In carrying out its duties, LPDP is responsible to the Minister of Finance through the Secretary General.



Susunan Organisasi LPDP sesuai dengan PMK Nomor 143/PMK.01/2016 tentang Organisasi dan Tata Kerja Lembaga Pengelola Dana Pendidikan terdiri atas:

### 1. Direktorat Keuangan dan Umum

Direktorat Keuangan dan Umum mempunyai tugas melaksanakan pengelolaan SDM dan organisasi, pengelolaan keuangan dan akuntansi, pengelolaan teknologi informasi, serta pengelolaan urusan umum pada LPDP. Direktorat Keuangan dan Umum terdiri atas 3 (tiga) divisi yaitu:

- Divisi Pengelolaan Sumber Daya Manusia dan Organisasi mempunyai tugas menyiapkan bahan dan penyusunan kebijakan teknis, pelaksanaan perencanaan, rekrutmen dan seleksi, penempatan, pengembangan, dan pemeliharaan SDM, pengelolaan dan pengembangan organisasi, pengelolaan kinerja, dan pelaporan atas pelaksanaan kegiatan pengelolaan SDM dan organisasi.
- Divisi Keuangan mempunyai tugas menyiapkan bahan dan penyusunan kebijakan teknis, pelaksanaan pengelolaan keuangan, setelmen, sistem dan prosedur akuntansi, serta pelaporan atas pelaksanaan kegiatan keuangan dan akuntansi.
- Divisi Teknologi Informasi dan Umum mempunyai tugas menyiapkan bahan dan penyusunan kebijakan teknis, penyusunan bahan dan penyusunan kebijakan teknis, pengelolaan dan pengembangan teknologi informasi, pelaksanaan urusan umum, kerumahtanggaan dan pengelolaan Barang Milik Negara, dan pelaporan atas pelaksanaan kegiatan teknologi informasi dan umum.

### 2. Direktorat Pengembangan Layanan dan Manajemen Risiko

Direktorat Pengembangan Layanan dan Manajemen Risiko mempunyai

The organizational structure of the LPDP is in accordance with PMK Number 143/PMK.01/2016 concerning the Organization and Work Procedures of Indonesia Endowment Fund for Education Agency consisting of:

### 1. Directorate of Finance and General Affairs

The Directorate of Finance and General Affairs has the task of carrying out HR and organizational, financial and accounting management, information technology, and general affairs management at the LPDP. The Directorate of Finance and General Affairs consists of 3 (three) divisions, namely:

- The Division of Human Resources and Organizational Management has the task of preparing materials and compiling technical policies, implementing planning, recruitment and selection, placement, development, and maintenance of HR, management and organizational development, performance management, and reporting on the implementation of HR and organizational management activities.
- The Finance Division is in charge of preparing materials and compiling technical policies, implementing financial management, settlement, accounting systems and procedures, as well as reporting on the implementation of financial and accounting activities.
- The Information Technology and General Division is responsible of preparing materials and compiling technical policies, managing and developing information technology, implementing general affairs, housekeeping and managing State Property, and reporting on the implementation of information technology and general activities.

### 2. Directorate of Service Development and Risk Management

The Directorate of Service Development and Risk Management has the task of

- Divisi Kerjasama dan Komunikasi mempunyai tugas menyiapkan bahan dan penyusunan kebijakan teknis, pelaksanaan kerjasama dan komunikasi, pengelolaan layanan informasi, serta pelaporan atas pelaksanaan kegiatan kerjasama dan komunikasi.
- Divisi Kepatuhan dan Manajemen Risiko mempunyai tugas menyiapkan bahan dan penyusunan kebijakan teknis pengelolaan kepatuhan dan manajemen risiko, perumusan dan penelaahan rancangan peraturan perundang-undangan serta pertimbangan hukum dalam rangka penyelesaian masalah hukum yang berkaitan dengan tugas dan fungsi LPDP serta pelaporan atas pelaksanaan kegiatan kepatuhan, manajemen risiko dan hukum.

### 3. Direktorat Investasi

- The Service Planning and Development Division is in control of preparing materials and compiling technical policies, preparing business strategic plans, business plans and annual budgets, work plans and work unit budgets, implementing service and business process development, monitoring and evaluating implementation as well as reporting on the implementation of planning activities. and service development.
- The Division of Cooperation and Communication is in charge of preparing materials and formulating technical policies, implementing cooperation and communication, managing information services, and reporting on the implementation of cooperation and communication activities.
- The Compliance and Risk Management Division has the task of preparing materials and compiling technical policies for compliance management and risk management, formulating and reviewing draft laws and regulations as well as legal considerations in the context of resolving legal issues related to the duties and functions of LPDP as well as reporting on the implementation of compliance activities, management risk and law.

### 3. Directorate of Investment

The Directorate of Investment has the task of carrying out planning,

The Directorate of Scholarship consists of 3 (three) divisions, namely:

- The Scholarship Recruitment and Selection Division is in control of preparing materials and compiling technical policies, managing and reporting on the implementation of recruitment, selection, and debriefing of scholarship recipients.
- The Scholarship Services Division has the task of preparing materials

- The Research and Rehabilitation Services Division is in charge of preparing materials and formulating technical policies, implementing research and rehabilitation facilitation and funding services, managing research and technology transfer results, monitoring and evaluating research and rehabilitation, as well as reporting on the implementation of research and rehabilitation services.






Pegawai dari segi Pendidikan per 31 Desember 2020

LPDP Employee Composition Based on Education as of December 31, 2020





In relation to the operational implementation of the LPDP, the Board of Trustees is tasked with providing strategic policy directions in the management of the Education Endowment Fund in accordance with Article 5 of Presidential Regulation Number 12 of 2019. The Board of Trustees' strategic policy directives stipulate at least:

- The proportion of the results of the development of the Education Endowment Fund that can be developed;

- Proporsi penggunaan hasil pengembangan Dana Abadi Pendidikan;
- Portofolio investasi Dana Abadi Pendidikan;
- Bidang prioritas pada program layanan; dan
- Kebijakan afirmasi pada program layanan dengan memperhatikan kondisi wilayah, kelompok masyarakat tertentu, dan/atau kebijakan pemerintah sesuai dengan ketentuan peraturan perundang-undangan.

### 2. Dewan Pengawas

Selain itu, Perpres tersebut juga menyatakan susunan Dewan Pengawas yang bertugas melaksanakan pengawasan sesuai dengan ketentuan peraturan perundang-undangan. Dewan Pengawas dalam hal ini ditetapkan oleh Menteri Keuangan.

Secara regulatif, Dewan Pengawas LPDP terdiri atas 7 (tujuh) orang dengan formasi sebagai berikut:

- 1 (satu) orang pejabat dari Kementerian Keuangan sebagai Ketua;
- 1 (satu) orang pejabat dari Kementerian Riset dan Teknologi;
- 1 (satu) orang pejabat dari Kementerian Agama;
- 1 (satu) orang pejabat dari Kementerian Pendidikan dan Kebudayaan;
- 3 (tiga) orang dari unsur tenaga ahli.

Dewan Pengawas saat ini masih menggunakan struktur yang lama, karena LPDP masih dalam tahap peralihan aturan. Selain itu, Peraturan Presiden mengamanahkan agar Dewan Pengawas melaksanakan rapat secara rutin paling sedikit 1 (satu) kali dalam sebulan. Keanggotaan Dewan Pengawas LPDP per tanggal 31 Desember 2020 adalah:

- The proportion of the use of the results of the development of the Education Endowment Fund;
- Investment portfolio of the Education Endowment Fund;
- Priority areas in the service program; and
- Affirmation policies on service programs by taking into account regional conditions, certain community groups, and/or government policies in accordance with the provisions of laws and regulations.

### 2. Supervisory Board

In addition, the Presidential Regulation also states the composition of the Supervisory Board in charge of carrying out supervision in accordance with the provisions of the legislation. The Supervisory Board in this case is determined by the Minister of Finance.

On a regular basis, the LPDP Supervisory Board consists of 7 (seven) people with the following formation:

- 1 (one) official from the Ministry of Finance as Chairman;
- 1 (one) official from the Ministry of Research and Technology;
- 1 (one) official from the Ministry of Religion;
- 1 (one) official from the Ministry of Education and Culture;
- 3 (three) people from the expert element.

The Supervisory Board is currently still using the old structure, because LPDP is still in the transitional stage of regulations. In addition, the Presidential Regulation mandates that the Supervisory Board hold regular meetings at least 1 (one) time a month. 




Layanan Pengembangan Dana LPDP dilaksanakan pada instrumen deposito, Surat Utang Negara (SUN), dan obligasi BUMN. Hal ini bertujuan untuk menjaga kestabilan nominal dana abadi tersebut di masa mendatang. LPDP Fund Development Services are implemented on deposit instruments, Government Securities (SUN), and BUMN bonds. This is intended to maintain the nominal stability of the endowment fund in the future. The results of the development of funds are recorded as Non-Tax State Revenue (PNBP) which is used to finance LPDP's services and operations.

Program Layanan Service Program

1. Layanan Pengembangan Dana Abadi Pendidikan

Pengembangan Dana Abadi Pendidikan merupakan salah satu layanan LPDP yang diamanahkan Peraturan Presiden Nomor 12 tahun 2019 tentang Dana Abadi Pendidikan. Dana Abadi Pendidikan dapat dikembangkan dalam bentuk investasi jangka pendek dan/atau jangka panjang pada surat berharga maupun nonsurat berharga di dalam dan/atau di luar negeri. Dalam menjalankan tugas pengembangan dana, LPDP dapat bekerjasama dengan pihak ketiga, dengan tetap mengedepankan praktik bisnis yang sehat dan risiko yang terkelola, serta memperhatikan prinsip tata kelola yang baik.

1. Education Endowment Development Services

The development of the Education Endowment Fund is one of the LPDP services mandated by Presidential Regulation Number 12 of 2020 concerning the Education Endowment Fund. The Education Endowment Fund can be developed in the form of short-term and/or long-term investments in domestic and/or foreign securities and non-securities. In carrying out the task of developing funds, LPDP can cooperate with third parties, while still promoting sound business practices and managed risks, as well as paying attention to the principles of good governance.

## 2. Layanan Beasiswa

Layanan Beasiswa yang diberikan LPDP memiliki *branding* “Beasiswa Pendidikan Indonesia” yang ditujukan untuk peningkatan aksesibilitas pendidikan tinggi bagi rakyat Indonesia. Layanan Beasiswa LPDP merupakan layanan beasiswa yang inklusif, dengan tetap mengedepankan aspek kualitas pendidikan. Pada tahun 2020, LPDP mendukung visi Kabinet Indonesia Maju yakni “SDM Unggul, Indonesia Maju”

Program Layanan Beasiswa LPDP dapat dijabarkan sebagai berikut:

### 1. Beasiswa Umum, diantaranya:

- **Beasiswa Dokter Spesialis**  
Program beasiswa ini diberikan kepada Dokter Umum yang ingin melanjutkan ke jenjang pendidikan Dokter Spesialis.
- **Beasiswa Perguruan Tinggi Peringkat Utama Dunia**  
Program beasiswa ini diperuntukkan bagi warga negara Indonesia yang telah memperoleh *Letter of Acceptance (LoA) Unconditional* dari Perguruan Tinggi Peringkat Utama Dunia yang ditetapkan LPDP. Para calon penerima beasiswa dapat melanjutkan pendidikan pada jenjang Magister dan Doktoral di luar negeri.
- **Beasiswa Kerjasama Pendanaan (Co-Funding)**  
Program Beasiswa *Co-Funding* (Beasiswa Semi Mandiri) diperuntukkan bagi warga negara Indonesia yang akan melanjutkan pendidikan pada jenjang Magister Luar Negeri program Reguler maupun program BPI Perguruan Tinggi Peringkat Utama Dunia. Sumber dana bagi pendaftar dapat berasal dari keluarga atau pendanaan pribadi.

## 2. Scholarship Service

Scholarship services provided by LPDP have the branding “Indonesian Education Scholarships” which are aimed at increasing the accessibility of higher education for the people of Indonesia. The LPDP Scholarship Service is an inclusive scholarship service, while still prioritizing aspects of the quality of education. In 2020, LPDP supports the vision of the Advanced Indonesia Cabinet, namely “Excellent HR, Advanced Indonesia”

The LPDP Scholarship Service Program can be described as follows:

### 1. General Scholarships, including:

- **Specialist Doctor Scholarship**  
This scholarship program is given to General Practitioners who wish to continue their education to Specialist Doctors.
- **World's Top Ranking University Scholarship**  
This scholarship program is intended for Indonesian citizens who have obtained an Unconditional Letter of Acceptance (LoA) from World's Top Ranking University established by LPDP. The scholarship recipients can continue their education at the Masters and Doctoral levels overseas.
- **Co-Funding Scholarship**  
The Co-Funding Scholarship Program (Semi-Independent Scholarship) is intended for Indonesian citizens who will continue their education at the Masters Overseas Regular program or the BPI program World's Top Ranking University. Sources of funding for applicants can come from family or personal funding.

## 2. Beasiswa Targeted Group, diantaranya: 2. Targeted Group Scholarships, including:

- **Beasiswa Pendidik Dosen**  
Program beasiswa yang ditujukan kepada dosen tetap pada perguruan tinggi yang diselenggarakan oleh Pemerintah maupun swasta untuk mengembangkan dan meningkatkan kualitas dosen sesuai kebutuhan strategis Perguruan Tinggi di Indonesia.
- **Beasiswa Pendidik Guru**  
Program beasiswa yang ditujukan kepada guru untuk mengembangkan dan meningkatkan kualitas guru di Indonesia.
- **Lecturer Educator Scholarship**  
The scholarship program is aimed at permanent lecturers at universities organized by the government and the private sector to develop and improve the quality of lecturers according to the strategic needs of universities in Indonesia.
- **Teacher Educator Scholarship**  
Scholarship program aimed at teachers to develop and improve the quality of teachers in Indonesia.

## 3. Layanan Pendanaan Riset

Program pendanaan riset yang dilaksanakan LPDP bernama Pendanaan Riset Inovatif Produktif (selanjutnya disebut Pendanaan RISPRO). RISPRO adalah program pendanaan riset baik kompetitif maupun inisiatif yang bertujuan untuk meningkatkan kemampuan daya saing bangsa melalui komersialisasi produk/teknologi atau implementasi kebijakan/tata kelola atau publikasi. Layanan Pendanaan Riset terdiri atas:

- **RISPRO Kompetisi**  
RISPRO adalah program pendanaan riset bersifat multidisiplin dan dilaksanakan dalam tahun jamak yang ditujukan untuk mendorong inovasi produk riset dan mengarah pada komersialisasi/implementasi luaran riset. RISPRO ditujukan bagi kelompok periset dari Badan Penelitian Kementerian/lembaga pemerintah, perguruan tinggi, lembaga riset industri dan lembaga riset swasta lainnya. RISPRO dibagi menjadi dua program, yaitu:
  1. **RISPRO Komersial**  
Dilaksanakan secara tahun jamak selama-lamanya tiga tahun

## 3. Research Funding Services

The research funding program implemented by LPDP is called Productive Innovative Research Funding (hereinafter referred to as RISPRO Funding). RISPRO is a research funding program, both competitive and initiative that aims to improve the nation's competitiveness through product/technology commercialization or implementation of policies/governance or publications. Research Funding Services consist of:

- **RISPRO Competition**  
RISPRO is a multidisciplinary research funding program and is implemented in multiple years aimed at encouraging research product innovation and leading to the commercialization/implementation of research outputs. RISPRO is intended for groups of researchers from Research Agency Ministries/government institutions, universities, industrial research institutions and other private research institutions. RISPRO is divided into two programs, namely:
  1. **Commercial RISPRO**  
It is carried out on a multi-year basis for a maximum of three years

2. RISPRO Implementatif

Program ini diarahkan pada penerapan luaran riset secara implementatif baik melalui penetapan kebijakan publik oleh regulator maupun penerapan luaran riset dalam rangka pemberdayaan masyarakat.

- RISPRO Mandatori  
Rispro Mandatori merupakan pendanaan riset yang dilaksanakan oleh PMO yang ditetapkan/ditunjuk oleh Dewan Penyantun LPDP berdasarkan arahan/kebijakan yang berasal Dewan Penyantun LPDP yang terdiri dari Prioritas Riset Nasional, Mobil Listrik Nasional, Ideathon dan Konsorsium Covid-19.
- RISPRO Invitasi  
Rispro Invitasi merupakan riset khusus yang ditujukan untuk pengembangan Kendaraan Listrik dan pengembangan Farmasi atau Alat Kesehatan.
- Riset Kolaborasi Internasional  
Rispro Kolaborasi Internasional merupakan riset yang dilaksanakan dengan model bisnis kerjasama pihak ketiga atau yang juga disebut *Grant Management*.

for the choice of research focus in the fields of food security, energy security, as well as health and nursing. This program is directed at the commercialization of research outputs on an industrial scale.

2. Implementative RISPRO  
It is carried out in multiple years for a maximum of two years for the choice of research focus in the fields of eco-growth, governance, socio-religious, and cultural research. This program is directed at implementing research outputs in an implementable manner, either through the establishment of public policies by regulators and the application of research outputs in the context of community empowerment. pemberdayaan masyarakat.

- RISPRO Mandatori  
Rispro Mandatori is research funding carried out by PMO which is determined/appointed by the LPDP Board of Trustees based on directions/policies originating from the LPDP Board of Trustees consisting of National Research Priorities, National Electric Cars, Ideathons and the Covid-19 Consortium.
- RISPRO Invitation  
Rispro Invitation is a special research aimed at developing Electric Vehicles and developing Pharmacy or Medical Devices.
- International Collaborative Research  
Rispro International Collaboration is research carried out with a third-party collaboration business model or also known as Grant Management.

### Kinerja Layanan Service Performance

#### 1. Dana Abadi Pendidikan

Sesuai dengan Bab I Ketentuan Umum Peraturan Presiden Nomor 12 tahun 2019 pasal 1 angka 1, disebutkan bahwa Dana Abadi Pendidikan adalah dana yang bersifat abadi untuk menjamin keberlangsungan program pendidikan bagi generasi berikutnya yang tidak dapat digunakan untuk belanja. Dalam Perpres tersebut, sumber Dana Abadi Pendidikan adalah:

1. Dana Pengembangan Pendidikan Nasional (DPPN) termasuk akumulasi alokasi tahun-tahun sebelumnya yang dikelola LPDP;
2. Pendapatan investasi dan/atau;
3. Sumber lain yang sah, yang dapat berupa hibah, hasil kerjasama dengan pihak lain, pendapatan alih teknologi hasil riset, royalti atas hak paten, dana pihak ketiga, dana perwalian, baik dari dalam maupun luar negeri dan/atau sesuai dengan ketentuan peraturan perundang-undangan.

Dana Abadi yang dikelola LPDP per 31 Desember 2020 berjumlah Rp70,107 Triliun. Jumlah tersebut adalah akumulasi dari DPPN sejak 2010 dan Dana Abadi lainnya yang dititipkan kepada LPDP.

Dana Abadi yang dikelola LPDP saat ini terdiri dari 4 jenis yakni Dana Abadi Pendidikan (DPPN) sebesar Rp61,1 Triliun, Dana Abadi Penelitian sebesar Rp4,99 Triliun, Dana Abadi Perguruan Tinggi sejumlah Rp3 Triliun, serta dicairkan juga Dana Abadi Kebudayaan sebesar Rp1 Triliun.

#### 1. Education Endowment

In accordance with Chapter I of the General Provisions of Presidential Regulation Number 12 of 2019 article 1 number 1, it is stated that the Education Endowment Fund is an enduring fund to ensure the continuity of education programs for the next generation that cannot be used for spending. In the Presidential Regulation, the sources of the Education Endowment Fund are:

1. The National Education Development Fund (DPPN) includes the accumulated allocations of previous years managed by LPDP;
2. Investment income and/or;
3. Other legitimate sources, which can be in the form of grants, the result of cooperation with other parties, income from technology transfer from research, royalties on patents, third party funds, trust funds, both from within and outside the country and/or in accordance with the provisions of laws and regulations.

The Endowment Fund managed by LPDP as of December 31, 2020 amounted to IDR 70,107 Trillion. This amount is the accumulation of DPPN since 2010 and other Endowments that have been deposited with LPDP.

The Endowment Fund managed by the LPDP currently consists of 4 types, namely the Education Endowment Fund (DPPN) of IDR 61.1 Trillion, the Research Endowment Fund of IDR 4.99 Trillion, the Higher Education Endowment Fund of IDR 3 Trillion, and the Cultural Endowment Fund of IDR 1 Trillion is also disbursed.


## 2. Investment Service

Investment income is income from the development of the Education Endowment Fund, as stated in Chapter II Sources of the Education Endowment Article 3 paragraph (2) of Presidential Regulation Number 12 of 2019. This investment income is categorized as Non-Tax State Income (PNBP).

As of December 31, 2020, the realization of PNBP was IDR 3.909 trillion from the target of IDR 3.73 trillion with an annualized yield of 7.65% p.a. of the 2020 yield target of 6.75% p.a. The details of the PNBP realization are as follows:

Pada bulan Maret 2020 Indonesia memasuki masa Tanggap Darurat karena wabah COVID-19. Selain itu pada bulan November 2020, Bank Indonesia menurunkan BI Reverse Repo Rate

In March 2020, Indonesia entered the Emergency Response period due to the COVID-19 outbreak. In addition, in November 2020, Bank Indonesia lowered the BI Reverse Repo Rate by 25 basis

sebesar 25 basis poin dari 4,00% menjadi 3,75%. Namun demikian, kinerja realisasi PNBP diharapkan tetap stabil meskipun pasar keuangan Indonesia mengalami tekanan yang cukup berat pada tahun 2020.

Namun demikian, meskipun dalam tekanan pasar keuangan yang cukup berat, LPDP mampu membukukan pendapatan sebesar Rp3,909 Triliun dengan *yield* 7,65% p.a. Tingkat Imbal Hasil tersebut menggambarkan kinerja LPDP yang tetap stabil meskipun ditengah pandemi COVID-19.

### 3. Layanan Beasiswa

Program Beasiswa LPDP bertujuan untuk menyiapkan pemimpin dan profesional masa depan Indonesia yang diharapkan dapat menjadi lokomotif kemajuan bangsa Indonesia. Pada tahun 2020, LPDP mendukung penuh pelaksanaan visi misi Presiden RI yakni "SDM Unggul Indonesia Maju" dengan memperluas akses pendidikan tinggi bagi seluruh rakyat Indonesia. Beasiswa

However, despite the fairly heavy financial market pressure, LPDP was able to record revenue of IDR 3.909 trillion with a yield of 7.65% p.a. The rate of return illustrates the performance of LPDP which remains stable even in the midst of the COVID-19 pandemic.

Furthermore, the LPDP portfolio as of December 31, 2020 can be summarized as follows:

### 3. Scholarship Service

The LPDP Scholarship Program aims to prepare Indonesia's future leaders and professionals who are expected to become the leaders who will drive the nation forward. In 2020, LPDP fully supports the implementation of the vision and mission of the President of the Republic of Indonesia, namely "Advanced Indonesian Through Superior Human Resources" by expanding access to higher education for all Indonesian





**4. Research Funding Services**

The research funding program implemented by LPDP is called the Indonesian Development Research Funding Program (RPI). This program is a leading research funding program directed at the commercialization/ implementation of research results so that it is expected to provide added value and/ or innovation. LPDP service performance achievements as of December 31, 2020 can be summarized as follows:

a. Number of Projects and Funding

Cumulatively as of December 31, 2020, LPDP has identified 892 projects (research titles) with a funding value of IDR 1.10 trillion. In 2020, there were 60 new contracts assigned with a contract value of IDR 498,895,540,629.00.

vehicles for the 5 state universities to increase TKDN on the platform which will be completed in 2022/2023. Also in 2020, LPDP has financed research related to COVID-19 in collaboration with the Ministry of Research and Technology/BRIN in accordance with the National Research Priority (PRN) of IDR 242.87 billion.

Progress of the implementation of the Research Funding Service policy during 2020 as follows:

1. **The COVID-19 Consortium**  
The COVID-19 Research Consortium is a collaboration between LPDP and the Ministry of Research and Technology / BRIN in dealing with the COVID-19 pandemic. The total funding commitment for this program is IDR 119 billion. As of December 31, 2020, LPDP has carried out research financing for 293 research titles with a total value of IDR. 117.82 billion, of which the realization of disbursement is IDR 78.19 billion.
2. **National Research Priority Research (PRN)**  
National Research Priority (PRN) is research financing that is a priority in collaboration with the Ministry of Research and Technology/BRIN. The total commitment for this research funding is IDR 250 billion, where so far LPDP has financed 305 research titles with a total value of IDR 242.87 billion. The realization of disbursement of research funds for this program as of December 31, 2020 was IDR 149.71 billion.
3. **MIT-Indonesia Research Alliance (MIRA) / IMPACT (Indonesia MIT Program for Advanced Research and technology)**  
This program has a total funding commitment of Rp961 billion for 5 fiscal years (2020 to 2024). The budget ceiling for this program is IDR 61 billion, but there has been no disbursement for this program in 2020.

#### 4. IDEATHON

IDEATHON memiliki total komitmen pendanaan sebesar Rp2 Miliar yang membiayai 17 judul riset dengan total nilai Rp1,14 Miliar. Pagu anggaran untuk program ini adalah Rp2 Miliar dengan realisasi Rp965,01 Juta per 31 Desember 2020.

Governance**1. Keterbukaan Informasi Publik**

Transparansi informasi adalah asas utama bagi instansi sektor publik yang bersinggungan langsung dengan pelaksanaan layanan kepada masyarakat luas. LPDP merupakan salah satu diantara instansi tersebut. LPDP melaksanakan pelayanan informasi publik berdasarkan Undang Undang Nomor 14 tahun 2008 tentang Keterbukaan Informasi Publik secara penuh dan konsekuen, sebagai bentuk komitmen LPDP terhadap persebaran informasi yang jelas dan merata kepada seluruh lapisan masyarakat. Sasaran utama informasi ini adalah para calon pendaftar beasiswa dan penerima bantuan dana riset LPDP.

Keterbukaan informasi LPDP diantaranya dilaksanakan secara langsung melalui kegiatan sosialisasi secara masif pada berbagai instansi pemerintah dan perguruan tinggi di seluruh Indonesia. Selain instansi dan perguruan tinggi yang memiliki potensi terbesar calon penerima beasiswa dan penerima dana riset, LPDP juga memberikan penyebaran informasi pada berbagai institusi non profit yang ikut serta dalam upaya meningkatkan akses pendidikan tinggi di Indonesia, misalnya melalui kegiatan atau pameran pendidikan. Target utama sosialisasi ini adalah daerah-daerah yang belum terjangkau informasi melalui media elektronik. Dengan sosialisasi secara masif dan menyeluruh di seluruh Indonesia, diharapkan jumlah persebaran pendaftar menjadi lebih merata sehingga seluruh masyarakat Indonesia dapat ikut menikmati akses terhadap pendidikan tinggi yang diberikan oleh LPDP.

Secara umum sampai 31 Desember 2020, LPDP telah melaksanakan 107 kegiatan sosialisasi pada berbagai kota di Indonesia (27 sosialisasi) serta pada berbagai platform daring (80 sosialisasi virtual). Selama jangka waktu tersebut, LPDP

**1. Public Information Disclosure**

Transparency of information is the main principle for public sector agencies, whose implementation of services are in direct contact with the wider community. LPDP is one of these institutions. LPDP carries out public information services based on Law Number 14 of 2008 concerning Public Information Disclosure in full and consequently, as a form of LPDP's commitment to clear and equitable distribution of information to all levels of society. The main targets of this information are prospective scholarship applicants and recipients of LPDP research grants.

LPDP's information disclosure is carried out directly through massive socialization activities in various government agencies and universities throughout Indonesia. In addition to institutions and universities that have the greatest potential for prospective scholarship recipients and recipients of research funds, LPDP also provides information dissemination to various non-profit institutions that participate in efforts to increase access to higher education in Indonesia, for example through educational activities or exhibitions. The main target of this socialization is areas that have not been reached by information through electronic media. With massive and comprehensive socialization throughout Indonesia, it is hoped that the number of registrants will be more evenly distributed so that all Indonesian people can gain access to higher education provided by LPDP.

In general, as of December 31, 2020, LPDP has carried out 107 outreach activities in various cities in Indonesia (27 outreach) and on various online platforms (80 virtual outreach). During this period, LPDP focused on

Selain itu, LPDP juga mengoptimalkan persebaran informasi melalui *social media* diantaranya Instagram, Facebook, dan LinkedIn. Persebaran informasi ini dinilai lebih efektif pada masa pandemi COVID-19 dibandingkan dengan sosialisasi secara daring. Program keberangkatan pun dilaksanakan secara daring untuk tetap

conducting remote socialization using video conferencing and/or webinars due to the Social Distancing policy set by the government, with the imposition of a ban on gathering large numbers of people.

In addition, LPDP also optimizes the distribution of information through social media including Instagram, Facebook, and LinkedIn. The dissemination of this information is considered more effective during the COVID-19 pandemic compared to online socialization. The departure program is also carried out online to

Jumlah *followers sosial media* LPDP merepresentasikan jumlah peminat beasiswa LPDP didominasi oleh generasi milenial, yang sangat *tech savvy* dan memiliki keterhubungan erat dengan penggunaan media sosial. With this business process, it is expected that responses to requests for information and complaints can be responded to quickly and on target so as to increase the level of satisfaction of LPDP service users. Dari keluhan tersebut, sekitar 99,55% permintaan informasi dan keluhan telah ditanggapi oleh tim CSO LPDP (tersisa 225 permintaan dalam proses penyelesaian). ## 2. Kerjasama Kelembagaan

From all the complaints, around 99.55% of requests for information and complaints have been responded to by the LPDP CSO team (the remaining 225 requests are in the process of being resolved). 

### 3. Manajemen Risiko

Profil risiko organisasi untuk tahun 2020 telah disusun dengan memetakan peta risiko yang mungkin dapat menghambat pencapaian visi dan misi dalam mewujudkan SDM Unggul Indonesia Maju.

Pada 2020, terdapat beberapa *highlighted risk* yang ditetapkan dalam peta risiko di antaranya:

1. Komplain dari pengguna layanan pada CRM terkait teknis aplikasi: Level 21
2. Komplain dari pengguna layanan pada CRM terkait respons keluhan dan permintaan informasi: Level 15
3. Portofolio penempatan dana tidak optimal: Level 15
4. Terdapat pelanggaran yang berindikasi *fraud* oleh pejabat/pegawai LPDP terutama terkait pemberian layanan kepada *customer*: Level 14
5. Terdapat rekomendasi audit/monev yang tidak dapat ditindaklanjuti: Level 13

### 4. Pemeriksaan Internal

Dalam pelaksanaan kegiatan asuransi, Satuan Pemeriksaan Internal (SPI) menggunakan pendekatan audit berbasis risiko sehingga sumber daya pemeriksaan dialokasikan paling besar untuk area yang memiliki tingkat risiko tertinggi antara lain yaitu pengelolaan beasiswa.

Di samping melaksanakan kegiatan pemeriksaan, SPI juga melakukan beberapa kegiatan di antaranya dengan mengelola pengaduan yang disampaikan masyarakat melalui *Whistleblowing System* Kementerian Keuangan, dan melaksanakan edukasi di bidang tata kelola dan pengendalian internal kepada pegawai.

Pada 2020, SPI telah melaksanakan beberapa kegiatan pemeriksaan yakni sebagai berikut:

### 3. Risk Management

An organizational risk profile for 2020 has been prepared which maps out a map of risks that might hinder the achievement of the vision and mission in realizing Advanced Indonesian Through Superior Human Resources.

In 2020, there are several highlighted risks defined in the risk map, including:

1. Complaints from service users on CRM, related to technical applications: Level 21
2. Complaints from service users on CRM, regarding response to complaints and requests for information: Level 15
3. Suboptimal fund placement portfolio: Level 15
4. Violations that are indicated as fraud by LPDP officials/employees, especially related to providing services to customers: Level 14
5. Audit/monitoring-evaluation recommendations that cannot be followed up: Level 13

### 4. Internal Audit

In the implementation of insurance activities, the Internal Audit Unit (SPI) uses a risk-based audit approach so that the largest allocation of audit resources is for areas with the highest risk level, including the management of scholarships.

In addition to carrying out inspection activities, SPI also carries out several activities including managing complaints submitted by the public through the Ministry of Finance's *Whistleblowing System*, and conducting education in the fields of governance and internal control to employees.

In 2020, SPI has carried out several inspection activities, namely as follows:

1. Review of Financial Reports for Semester I and Semester II of 2019 and Assessment of the Effectiveness of Internal Control in Financial Reporting for 2019.
  2. Evaluation of the language enrichment program at two universities in Yogyakarta with the outputs in the form of two minutes of the evaluation of the language preparation program.
  3. Evaluation of the implementation of the clauses in the cooperation agreement between LPDP and domestic study destination universities at 7 universities that regulate the exchange of data and information with study destination universities, mostly conducted online.
  4. Monitoring effectiveness of the Directorate of Scholarship in managing the Indonesian Education Scholarship Program which includes implementation, accountability, monitoring and evaluation with the output of 1 (one) evaluation report on the management of the program. This activity is carried out online.
  5. Examination of scholarship recipients' compliance with the President Director's Regulations related to scholarships with an output in the form of 2 Examination Result Reports for violations committed by scholarship recipients. Examination of alleged violations by scholarship recipients is carried out on the basis of requests and follow-up to BPK (State Finance Agency) findings.
  6. Examination in order to follow up on complaints submitted by employees or the public through the Ministry of Finance's WiSE, CRM application and email complaints with the outputs of 11 Material and Information Collection Reports and 3 Investigative Inspection Results Reports. Five examinations were conducted online.
1. Reviu Laporan Keuangan Semester I dan Semester II Tahun 2019 serta Penilaian Efektivitas Pengendalian Intern Pelaporan Keuangan Tahun 2019.
  2. Evaluasi atas program pengayaan bahasa pada dua universitas di Yogyakarta dengan luaran berupa dua berita acara hasil evaluasi program persiapan bahasa.
  3. Evaluasi atas pelaksanaan klausul perjanjian kerja sama antara LPDP dengan perguruan tinggi tujuan studi dalam negeri pada 7 perguruan tinggi yang mengatur pertukaran data dan informasi dengan perguruan tinggi tujuan studi, sebagian besar dilaksanakan secara daring.
  4. Pemantauan atas efektivitas Direktorat Beasiswa dalam mengelola program Beasiswa Pendidikan Indonesia yang meliputi pelaksanaan, pertanggungjawaban, *monitoring* dan evaluasi dengan luaran berupa 1 laporan hasil evaluasi atas pengelolaan program Beasiswa Pendidikan Indonesia. Kegiatan ini dilaksanakan secara daring.
  5. Pemeriksaan atas kepatuhan penerima beasiswa terhadap Peraturan Direktur Utama terkait beasiswa dengan luaran berupa 2 Laporan Hasil Pemeriksaan atas pelanggaran yang dilakukan oleh penerima beasiswa. Pemeriksaan atas dugaan pelanggaran oleh penerima beasiswa dilaksanakan atas dasar permintaan dan tindak lanjut temuan BPK.
  6. Pemeriksaan dalam rangka tindak lanjut pengaduan yang disampaikan pegawai atau masyarakat melalui WiSE Kementerian Keuangan, aplikasi CRM dan email pengaduan dengan luaran berupa 11 Laporan Pengumpulan Bahan dan Keterangan dan 3 Laporan Hasil Pemeriksaan Investigatif. Lima pemeriksaan dilaksanakan secara daring.

7. Pengelolaan pengaduan melalui WiSE Kementerian Keuangan yang dilakukan sepanjang tahun.
8. Penyampaian pengaduan kepada direktorat terkait untuk ditindaklanjuti.
9. Dalam rangka pelaksanaan kegiatan konsultasi, SPI telah melakukan Asistensi Penyusunan *Fraud Risk Scenario* dan *Risk Control Matrix*, pelatihan kepada pegawai terkait Konsinyering Pelatihan Pemeriksaan dan Penyusunan LHP, serta Konsinyering Pelatihan Kegiatan Operasi Tertutup. Kegiatan tersebut mengundang Inspektorat Jenderal sebagai narasumber.
10. Selama pandemi, SPI juga turut aktif mengikuti beberapa seminar dan pelatihan yang dilaksanakan secara daring.

Dari sisi kinerja, SPI telah melakukan tindak lanjut atas rekomendasi audit. Rekomendasi audit tersebut telah selesai ditindaklanjuti/ditetapkan tuntas. SPI dalam hal ini berkoordinasi secara intensif dengan pemeriksa eksternal maupun APIP Kementerian Keuangan. Kinerja SPI ini dihitung berdasarkan penyelesaian rekomendasi kebijakan dan rekomendasi hukuman disiplin yang kemudian dirata-rata tingkat capaiannya.

Capaian untuk kinerja SPI ini pada 2020 adalah 100% dari target 100%. Untuk tindak lanjut rekomendasi kebijakan, dari target 18 rekomendasi temuan pada audit kinerja BPK, 18 temuan tersebut telah ditindaklanjuti dan diusulkan untuk tuntas. Selain itu, dari target 26 rekomendasi audit Inspektorat Jenderal, kesemuanya (26 temuan) juga telah diusulkan untuk tuntas. Pada 2020, tidak ada rekomendasi temuan hukuman disiplin atas pegawai.

7. Complaint management through the Ministry of Finance's WiSE which is carried out throughout the year.
8. Submission of complaints to the relevant directorate for follow-up.
9. In order to carry out consulting activities, SPI has provided assistance in the preparation of *Fraud Risk Scenarios* and *Risk Control Matrix*, training for employees related to the *Consignment Training for Examination and Preparation of LHP*, as well as *Consigning Training for Closed Operations Activities*. The activity invited the *Inspectorate General* as a resource person.
10. During the pandemic, SPI also have been actively participating in several online seminars and training.

In terms of performance, SPI has followed up on audit recommendations. The audit recommendation has been followed up/determined to be complete. In this case, SPI coordinates intensively with external auditors and the APIP of the Ministry of Finance. The performance of this SPI is calculated based on the completion of policy recommendations and recommendations for disciplinary punishment which are then averaged for the level of achievement.

The achievement for this SPI performance in 2020 is 100% of the 100% target. For the follow-up to policy recommendations, from the target of 18 recommendations for findings in the BPK performance audit, 18 of these findings have been followed up and proposed to be completed. Besides, from the target of 26 recommendations of the Inspector General's audit, all have also been proposed for completion. In 2020, there are no recommendations for finding disciplinary penalties for employees.



## 5. Survei Kepuasan Publik

Sebagai bentuk akuntabilitas dan pertanggungjawaban publik, LPDP melakukan pengukuran Indeks Kepuasan Publik atas Layanan LPDP sesuai dengan Indeks Kepuasan Publik pada Kementerian Keuangan. Kepuasan layanan publik diukur berdasarkan hasil survei kepuasan publik oleh lembaga independen berdasarkan pemenuhan atas asas penyelenggaraan pelayanan publik sesuai Undang Undang Nomor 25 Tahun 2009.

Pada periode September s.d. Desember 2020, LPDP telah melaksanakan Survei Kepuasan Publik atas Layanan (SKPL) tahun 2020 bekerjasama dengan konsultan independen dari Institut Pertanian Bogor (IPB). Survei dilaksanakan pada penerima beasiswa dan pendanaan riset, serta kinerja operasional perkantoran LPDP. Survei bertujuan untuk mengetahui tingkat kepuasan para penerima layanan LPDP, yang pada

## 5. Public Satisfaction Survey

As a form of accountability and public responsibility, LPDP measures the Public Satisfaction Index for LPDP Services in accordance with the Public Satisfaction Index at the Ministry of Finance. Public service satisfaction is measured based on the results of a public satisfaction survey by an independent institution based on the fulfillment of the principles of public service delivery in accordance with Law Number 25 of 2009.

In the period of September to December 2020, LPDP has carried out the 2020 Public Satisfaction Survey on Services (SKPL) in collaboration with an independent consultant from the Bogor Agricultural University (IPB). The survey was conducted on recipients of scholarships and research funding, as well as the operational performance of LPDP offices. The survey aims to determine the level of satisfaction of LPDP service recipients, which in turn





The survey was carried out using an online method, both for distributing questionnaires and for Focus Group Discussions (FGD), which were also conducted online. This year, for the first time, LPDP was able to conduct a survey for recipients of overseas cluster scholarships because previously FGDs were only for recipients of domestic scholarships.

The survey respondents in 2020 amounted to 3,985 people for scholarship services and 56 recipients of research funds with a total satisfaction of 4.37 out of a scale of 5. The results of the survey per service can be broken down as follows:

## 2. Dukungan Program Kampus Mengajar Perintis

Pada tahun 2020, LPDP memberikan dukungan terhadap Program Kampus Mengajar Perintis dari Kementerian Pendidikan dan Kebudayaan. Kampus Mengajar Perintis (KMP) merupakan salah satu program dari Kampus Merdeka: Merdeka Belajar dalam rangka memberi ruang bagi mahasiswa untuk bergerak di luar kampus, yakni dengan kegiatan belajar mengajar pada satuan pendidikan dasar dan menengah. Program KMP merupakan rintisan dari Program Kampus Mengajar dengan sasaran utama sekolah dasar di sekitar domisili mahasiswa. Diharapkan mahasiswa dapat meningkatkan APK Indonesia dengan adanya program ini.

Seleksi Program KMP dilaksanakan oleh Kementerian Pendidikan dan Kebudayaan untuk lalu didanai oleh LPDP. Per 31 Desember 2020, peserta Program KMP yang berhasil lolos seleksi sebanyak 2.389 orang.

## 3. PMK Struktur Organisasi Baru

Pada tahun 2020 ini, LPDP juga telah memiliki struktur Organisasi dan Tata Kerja yang baru dengan ditetapkannya Peraturan Menteri Keuangan Nomor 47/PMK.01/2020 tentang Organisasi dan Tata Kerja Lembaga Pengelola Dana Pendidikan. PMK tersebut menggantikan PMK Nomor 143/PMK.01/2016 tentang Organisasi dan Tata Kerja Lembaga Pengelola Dana Pendidikan yang sudah tidak berlaku sejak PMK tersebut diundangkan. Implementasi PMK 47/PMK.01/2020 tersebut dapat dilaksanakan paling lama 1 (satu) tahun terhitung sejak PMK tersebut diundangkan.

## 2. Pioneer Teaching Campus Program Support

In 2020, LPDP provides a support for the Pioneer Teaching Campus Program from the Ministry of Education and Culture. Campus Teaching Pioneers (KMP) is one of the programs of the Merdeka Campus: Merdeka Learning in order to provide space for students to move outside the campus, namely by teaching and learning activities in primary and secondary education units. The KMP program is a pilot of the Teaching Campus Program with the main target being elementary schools around the student's domicile. With a full of hope that students can increase the Indonesian APK with this program.

The KMP program selection is carried out by the Ministry of Education and Culture and then funded by the LPDP. As of December 31, 2020, there were 2,389 KMP Program participants who had passed the selection.

## 3. PMK New Organizational Structure

In 2020, LPDP also has a new Organizational and Work Procedure structure with the enactment of Minister of Finance Regulation Number 47/PMK.01/2020 concerning Organization and Work Procedure of Indonesia Endowment Fund for Education Agency. The PMK replaces PMK Number 143/PMK.01/2016 concerning the Organization and Work Procedure of the Indonesia Endowment Fund for Education Agency which has been invalid since the PMK was promulgated. The implementation of PMK 47/PMK.01/2020 can be carried out no later than 1 (one) year from the date the PMK was promulgated.
